Policy & Conditions:

The Village Trolley has a capacity of 30 passengers. Smoking is not permitted on the trolley. No standing while the trolley is in motion. Except for seeing-eye dogs, animals are not permitted on the trolley, except by special contract. Customer decorations must be approved and displayed by Village Trolley staff only. Beverages and food must be in covered containers. Trolley must be left in the same condition as when the event commenced. Customer will reimburse Village Trolley for cleaning costs and/or any and all damages as a result of applicant's use of Village Trolley.

Customer shall indemnify and hold Village Trolley harmless from and against all personal injuries and property damage including court costs and reasonable attorney fees arising out of or in any way related to these services and this Event provided there was no gross negligence on the part of Village Trolley. If Village Trolley is unable to provide the trolley services contemplated herein for any reason, then Customer's sole and exclusive remedy for said default by Village Trolley shall be the repayment by Village Trolley to Customer of the deposit or payment previously paid.

Fee Schedule:

One hour local tour will be charged a rate of \$200 per hour and \$300 for pickups outside Elk Grove Village. Travel time, if applicable, will be charged \$50 per half hour drive time to and from the pickup location. **The charter fee is payable and due with signed contract to reserve day.** The fee is non-refundable unless Village Trolley deems conditions are non-suitable for completion of charter. Any charges for fees for additional time including travel time and/or costs for cleaning and/or damages to Village Trolley, shall be paid by Customer at time of service. Any amounts not paid as provided herein shall accrue interest at a rate of 18% per annum, and Customer agrees to pay all of Village Trolley's costs of collection of unpaid amounts due, including court costs and reasonable attorney's fees.
